



Briefing for the Community Brighton Photography Competition

Are you or someone you know a keen photographer?

On July 2 Sussex Police is launching a photo competition under the theme of 'Community Brighton' and are inviting Brighton and Hove residents to send in their photographic entries to share what community in Brighton and Hove means to you.

Do you want to take part in our competition in capturing our community? Would you like your work to be displayed in our front office?

We want to use space in the foyer of the front office to be for the public, by the public and reflect the diverse people who live and work here.

We encourage entrants to send us photos of what Community Brighton means to you, whether it's people, landscapes, buildings or streets.

The winning photographs will be part of a display within the foyer at John Street Police Station.

How to enter

- Photo competition opens Thursday 2 July
- Photo competition closes Thursday 9 July (by 23:59)

Please send your photos by email to brightonandhove@sussex.pnn.police.uk, Photos will be accepted in JPG, PSD, PNG or EPS formats only and must be a minimum of 2016 x 3040 pixels and under 10MB in file size.

By submitting your best photo, you confirm you have read our terms and conditions that set out important rules around consent and rights below.

SUSSEX POLICE BRIGHTON AND HOVE DIVISION FACEBOOK PHOTO COMPETITION TERMS AND CONDITIONS

DURATION

- The Competition is open to entries from midnight Thursday 2 July 2020 until 23.59 Thursday 9 July 2020.

ELIGIBILITY

- Entrants must be UK residents, aged sixteen (16) years or over.

HOW TO ENTER

- To enter this Competition, entrants must:
 1. Send a photograph that best shows what living, working and visiting Brighton is like to the following email address including your first name, last name and postcode.
 2. By supplying this information above you confirm you have read and accepted the SUSSEX POLICE BRIGHTON AND HOVE DIVISION FACEBOOK PHOTO COMPETITION terms and conditions.
 3. No purchase is necessary to enter this promotion however internet access is required.
 4. Invitations to enter the Competition will be made on Sussex Police social media between Thursday 2 July 2020 and Thursday 9 July 2020.
 5. The Promoter reserves the right to discount any inappropriate or offensive entries and to disqualify any entries if the Promoter, at its sole discretion, believes that there has been an attempt to manipulate or tamper with the operation of the promotion.

ENTRY REQUIREMENTS AND RESTRICTIONS

- Entries should be submitted by email through brightonandhovepolice@sussex.pnn.police.uk
- All images submitted must be original work of the individual submitting them and must not have been published elsewhere or have won a prize in any other photographic competition.
- All entries must be received by the advertised closing time and date.
- Late, illegible, incomplete, defaced or corrupt entries will not be accepted. No responsibility can be accepted for lost entries and proof of transmission will not be accepted as proof of receipt.
- The winning entry will be that which is judged to be the most visually appealing, original image which celebrates the culture and diversity within the community of Brighton and Hove
- Entries submitted on behalf of another person will not be accepted and joint submissions are not allowed. Incomplete, illegible, misdirected or late entries will not be accepted.
- Entry forms shall be deemed to be submitted at the date and time of receipt as determined by Sussex Police.

THE WINNER SELECTION

- Copyright in all images submitted for this competition remains with the respective entrants however, as a condition of entry in to the competition, each entrant grants a royalty free, worldwide, irrevocable, perpetual licence to Sussex Police to feature any or all of the submitted images in any of their publications, their websites and/or in any promotional material.
- The winners of the competition will be selected from entries received during the promotional period via the Brighton Independent Advisory Group.
- The winners of the competition will be notified by email the week commencing 20 July 2020.
- Photographs will be displayed in John Street Police Station where there is public access for viewing with social distancing measures in place.
- In the event of unforeseen circumstances or circumstances outside its reasonable control, the Promoter reserves the right to modify or discontinue, temporarily or permanently, this promotion without prior notice.
- All winners of the competition will receive a framed photograph of their entry between Monday 3 August 2020 – Friday 7 August 2020, by recorded delivery, to the address supplied by the winners.

WINNER NOTIFICATION

- The Winners will be notified within ten (10) working days of the Competition via email and announced on social media as set out on the entry form (“Notification”). Winners will have five (5) working days from the time the Notification is sent to respond and provide their full name and address and submit a valid form of identification, this can take the form of a scanned copy of a driving license or passport. A prize will be forfeited if:
 1. The Winner fails to respond within five (5) working days of this notification; or
 2. the Winner declines the Prize; or
 3. the Prize is returned as undelivered;

- The name and county of residence of the Winner will be made available on request to anyone sending a stamped self-addressed envelope to the Promoter at the address set out above within 10 weeks of the closing date of the Competition.
